

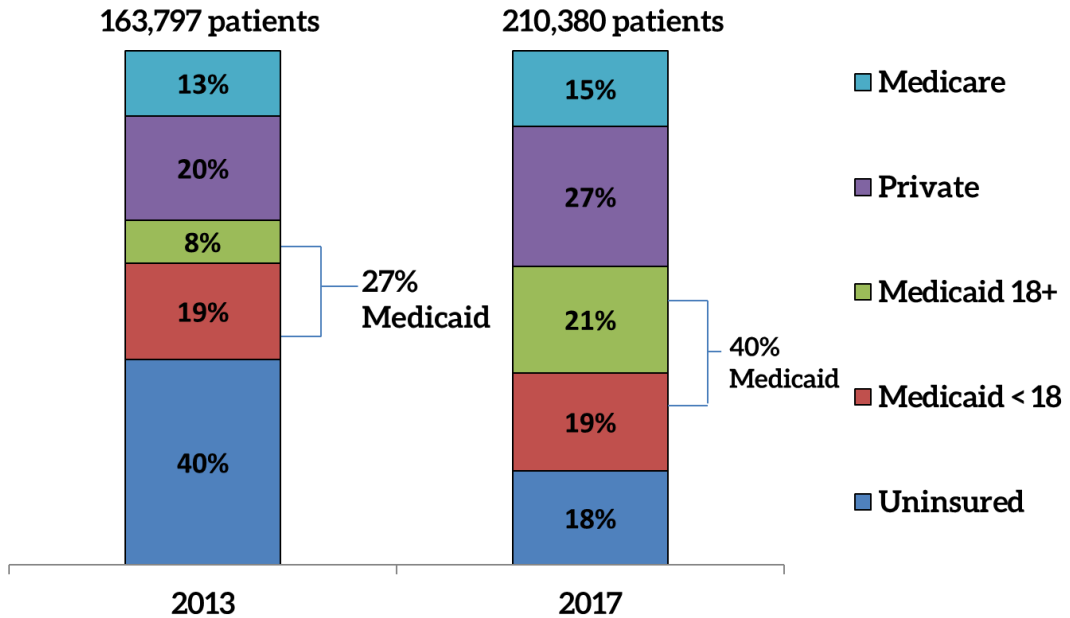

Figure 1. Health Insurance Coverage of Arkansas Health Center Patients, 2013 and 2017



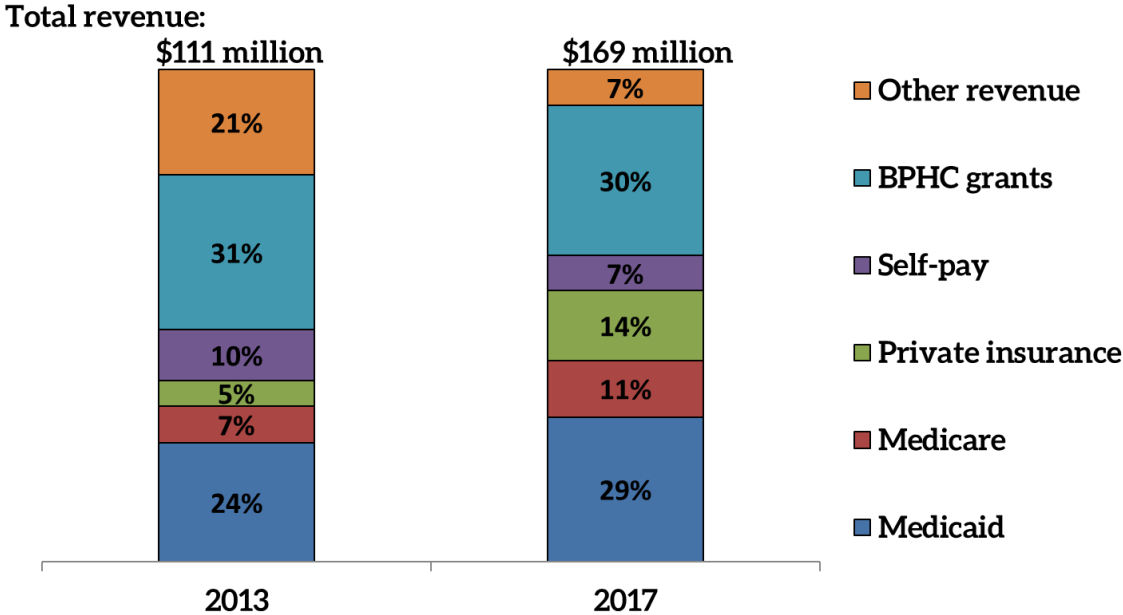
